Tooless Enclosure Assembly

1. Open the enclosure door by sliding the release switch.

- 2. SATA Data Port







2. Slide the 2.5" SATA hard drive into the enclosure with the label facing upward into the 2.5" Hard drive slot.



3. Press the enclosure door closed so that the release switch clicks back into place.



4. Enclosure Assembly is now complete.
